It is time to nominate Officers and Directors for the upcoming 2022 calendar year. Per the bylaws, we are seeking nominations for the following positions:

**President-Elect** (*3-Year Commitment*) – Serves an important role in policy-making decisions as well as leading the annual operations of the organization. The office of President Elect is a three-year commitment, as the President-Elect progresses to President (2023) and Past President (2024). As President-Elect, the elected nominee will chair the 2022 Annual Conference, as President will preside over the organization and as Past President will handle the elections of the organization. Please give serious thought to accepting the nomination for this important position. Bylaws require in order to be nominated for this position, the member must have either 1) attended a minimum of two past Annual Business Meetings or 2) previously served on the Board of Directors. This position in the organization is vacated annually by natural progression.

**Treasurer** (*2-Year Commitment*) – The Treasurer manages the receipt of membership funds, payment of conference costs, dissemination of scholarship funds, and adherence to the budget, as well as other items requested by the Board.

**Regional Directors** (*2-Year Commitment*) – Regional Directors represent specific geographical areas as voting members of the Board of Directors and facilitate local events and encourage membership, most effectively with the help of a regional committee. Directors serve a two-year term in order to provide continuity on the Board.

**PLEASE NOTE: Only members in active status who are current on their membership dues are eligible to run for an elected position or nominate other active members for an elected position. A nominee must receive a minimum of two nominations to be eligible to run for an elected position.**
